2023-2024 Payment Information

The Ferris State University Board of Trustees approved the **2022-2023** dual enrollment tuition rate of \$298 per credit hour for Ferris courses. The approved rate for KCAD courses is \$315 per credit hour for Art courses and \$298 per credit hour for general education courses. *The per credit hour rate is not guaranteed and tuition rates are subject to change in July of 2023.* There is an additional \$12 fee per credit hour for online courses.
